MICHAEL ANDERS – BROTHER BOOGIE

Michael Anders — Brother Boogie, as he's known on the street — is "from Omaha, Nebraska. When I got out of the Army, I came to St. Louis. I later met Alice. She divorced me after I robbed the bank where she worked. But through God's help, he's restored that marriage.

"My bank robbing started in 1991 to feed my gambling addiction. I robbed two banks: Boatmen's Bank in Clayton and a Mercantile Bank, where my wife was employed, She had no idea what I was doing, and she almost lost her job.

"The day I received my freedom was June 12, 1992. I was 46. That's when federal marshals surrounded me and arrested me. I had the amazing opportunity to go to prison. I was sentenced to 10 years for the two armed bank robberies and was paroled early. It was in prison where I met "His Amazing Grace," and my life has not been the same.

"Jesus told me to start my own business and hire ex-offenders, and to call it CONS, "Convicts Once, Now Saved." When the Lord gives you a "vision," he will give you a "provision." I received \$100,000 from AmerenUE to get our two trucks. And that's what started the moving company." He has been assembling his crews of former convicts for the last seven years from his base at Washington and Taylor.


